

Dear Friends and Supporters,

The legacy of Robert H. Jackson, a leading political figure of the 20th Century, continues to be relevant in today's world. As our Annual Newsletter reports, Justice Jackson's impact and his work can be found in the American judicial world, international tribunals and classrooms around the nation.

As a part of the Center's recent Strategic Plan, this year we recommitted to pursuing innovative ways to present Jackson's legacy with a new defined

tagline, "Promoting Liberty under Law." Within the phrase is a direct quotation from Justice Jackson's famous 1954 speech, Liberty under Law, addressing the New York State Bar Association. The speech historically traces and underlines why liberty cannot survive without the rule of law. The tagline focuses on the principles of free speech and how citizens cannot pursue the ideals of equality, fairness and justice that Jackson upheld throughout his career, without the protection of laws. The tagline also provides a defined strategic focus for the Center as we continue to promote these principles through our ongoing programs, events and exhibits.

This evening, as we come together for the 2015 Annual Dinner I am pleased to be able to report on yet another tremendous year for which many of you have been a part.

Some highlights include:

- Continued excellence in *programming* with a 75th Anniversary program this spring on Jackson's Federal Prosecutor speech, hosted by U.S. Attorney William J. Hochul; and the 11th annual Robert H. Jackson Lecture on the Supreme Court with Professor Laurence H. Tribe. Both programs underscored Jackson's relevance in today's judicial world.
- The completion and acquisition of the *feature-length documentary* Liberty under Law: The Robert H. Jackson Story that will now be able to serve as a tool to increase the Center's visibility and share Jackson's story with the world.
- The expanded reach of our Youth Education Initiative that provides programming for area students, regional educator workshops, an annual Teacher Fellowship Program and the National Award for Teaching Justice.
- Finally, this past month the Center launched a *redesigned website*. It will now be more interactive and host educational resources providing users a better experience when accessing our site.

U.S. Attorney William J. Hochul Hosts Program at Jackson Center

The 75th Anniversary program on Attorney General Robert H. Jackson's Speech: *The Federal Prosecutor* was held on Thursday April 9th, 2015 at the Jackson Center. The event, hosted by United States Attorney William J. Hochul, Jr., examined the continued relevance of Attorney General Jackson's 1940 speech, *The Federal Prosecutor*. Delivered during the Second Annual Conference of the United States Attorneys in 1940, the speech

Documentary Premiere: Liberty Under Law

This spring the Jackson Center secured ownership rights to the documentary titled, *Liberty under Law: The Robert H. Jackson Story*. This acquisition completed an ambitious project initiated several years ago by Lisa and Rich Gensheimer of Main Street Media to produce a feature-length film on Justice Jackson. In celebration of the documentary's completion, the Center hosted a world premiere of *Liberty Under Law* on May 4, 2015. A special introductory panel was held prior to the screening of the film with distinguished guests Julia Craighill, Jackson's granddaughter, Father Moritz Fuchs, Jackson's bodyguard at Nuremberg and David Crane, former Chief Prosecutor for the Special Court of Sierra Leone. The premiere notably coincided with the anniversary of Justice Jackson's appointment as Chief U.S. Prosecutor and begins the Center's 18 month commemoration of the 70th anniversary of the Nuremberg Trial.

Tribe Delivers Lecture on Supreme Court

The 11th annual Robert H. Jackson Lecture on the U.S. Supreme Court was delivered by Harvard Law School professor, Laurence H. Tribe. Tribe is a leading scholar, teacher and writer on the Constitution of the United States, the Supreme Court, and constitutional law and history. During his lecture Tribe shared his views and opinions on today's U. S. Supreme Court and their connection to Justice Jackson's legacy. Tribe joins a selective group of individuals who have headlined Chautauqua Institution's Robert H. Jackson Lecture on the Supreme Court.


70th Anniversary of IMT at Nuremberg

2015-2016 marks the 70th anniversary of the trial of major Nazi war criminals before the International Military Tribunal (IMT) at Nuremberg. The Jackson Center will commemorate this important historical anniversary with a series of programs and events. The Center will debut a new exhibit titled, *A Grave Responsibility: Jackson at Nuremberg*. The exhibit will feature a timeline of the Trial based on Jackson's own words with photographs from the Harry S. Truman Library and the United States Holocaust Memorial Museum. Additionally, the Center's educational activities for the next year will focus on the 70th anniversary theme. Throughout the year the Center will be working in collaboration with local school districts in Warren County, Pennsylvania and Chautauqua County, New York to present *This Day in Nuremberg*, a project featuring historical content on the Trial prepared by area students

Youth Education Initiative

Through our Youth Education Initiative the Jackson Center continues to strengthen its mission and strategic focus, which aims to actively show the relevance of Justice Jackson's work in today's world. The Youth Education Initiative provides outreach and programming for students throughout the year, educator development with semi-annual teacher workshops and an annual fellowship program, as well as educator recognition with a National Award for Teaching Justice. It is through these activities the Center seeks to expand the knowledge and legacy of Justice Jackson by reaching today's youth in classrooms around the region, country and beyond. Teacher Fellows

Melissa Becker is a 12th grade social studies teacher and Department Chair at Warren Area High School in Warren, PA. In her Fellowship project, "Jackson: Roots, Memory, and Legacy," Ms. Becker's 12th grade students studied Jackson's biography and created projects to teach 5th and 7th



grade students about his life and achievements.



Caroline Hayes is a 6th grade Social Studies and English Language Arts educator at Youngsville Elementary Middle School in Warren County, PA. Her Fellowship project for the Center linked the past to the present by having her students write, produce, perform and publish speeches on Justice Jackson's life

and legacy affectionately nicknamed "Bob Talks."

Daiman Parinella is a 7th and 8th grade Social Studies teacher at Washington Middle School, Jamestown, NY. His Fellowship project titled Youth Leadership Summit worked on students building their skills in public speaking, critical writing and



community service while learning about the life of Justice Jackson.
