



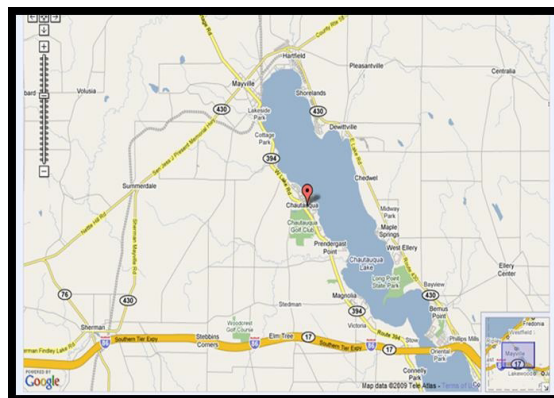
Robert Krueger, former U.S. Senator and Ambassador to Burundi, with Whitney and Anna Harris at the 2008 International Law Dialogs.

Whitney Harris is a graduate of the University of Washington and the University of California School of Law at Berkeley. He is author of *Tyranny on Trial: The Trial of the Major German War Criminals at the End of World War II at Nuremberg Germany*; *The Tragedy of War*; and *Murder by the Millions: Rudolf Hoess at Auschwitz*. Harris was a prosecutor at the Nuremberg Trials with Robert H. Jackson, Director of the Hoover Commission's Legal Services Task Force, and served as the first Executive Director of the American Bar Association. He was also a delegate to the UN-sponsored Rome conference that resulted in the treaty that created the International Criminal Court. In December 2001, Washington University in St. Louis renamed its Institute for Global Legal Studies the Whitney R. Harris World Law Institute.

HONORING WOMEN IN INTERNATIONAL CRIMINAL LAW

FROM NUREMBERG TO THE ICC (INTERNATIONAL CRIMINAL COURT)

The third annual International Humanitarian Law Dialogs, co-sponsored by the Robert H. Jackson Center at the Chautauqua Institution, is an historic gathering of international prosecutors from Nuremberg through present day tribunals. The sessions are free and open to the public (with the exception of meals). This 2009 installation of the Dialogs will bring together renowned prosecutors to honor and discuss the role of women in international criminal law.

Justice Robert H. Jackson was United States chief prosecutor of the principal Nazi war criminals at the International Military Tribunal in Nuremberg, Germany, during 1945-46. Nuremberg was the first successful international effort to hold individuals criminally responsible for planning and waging aggressive war, committing war crimes and committing crimes against humanity. It founded the era of international criminal law and set standards that guide international prosecutors today.
